## AfterLight, After Loss Checklist

#### To be completed by family members

- Notify family and friends
- Set up care for any dependents or pets
- Secure homes and cars
- Dispose of food or other perishable items in the home
- Plan funeral, memorial service or celebration of life (keep record of expenses)
- Write an obituary
- Set up an online memorial website (see recommendations below)
- Obtain multiple copies of the death certificate
  - We recommend getting 10-15 original copies
  - Please make sure SS#, DOB, DOD and Birthplace are correct
- Locate and gather important documents and information
- Contact the Social Security office
- Freeze credit cards & place freeze w/ creditors (see digital estate checklist below)
- Notify the Executor of the Will
- Notify broker, attorney, financial planner, accountant, etc.
- Notify the post office and have mail forwarded
- Notify Veterans Affairs
- Contact landlord
- Contact loved one's employer
- Notify life, health, auto, homeowner's insurance agencies
- Access and cancel accounts (see digital estate checklist below)
- Notify DMV/Voter's registration
- Check the contents of any safety deposit boxes (have 2 people present)
- Work with a CPA to file the loved one's income tax returns
- Investigate the following:
  - Social Security Benefits
  - Life Insurance
  - Union Death benefits
  - Veteran's burial allowance and Veteran's benefits
  - Retirement Employee benefits such as IRA accounts, pension, retirement plan, etc.
  - Medical reimbursements and refunds on insurance and/or subscriptions

## AfterLight, After Loss Checklist

#### To be completed under Attorney's guidance

- Review and analyze the Will and/or Trust
- File for Administration of Estate or Probate of Will, if needed
- Evaluate joint accounts and assets (such as bank accounts, real estate, safe deposit boxes, brokerage accounts)
- Complete duties as personal representative/executor of the estate

### Digital Estate Guidelines



According to a recent study, the average online user has 207 accounts. These online accounts, as well as other digital property including hardware, software, tablets, etc., comprise what we refer to as your "Digital Estate." Furthermore, many accounts have extended services within that company (e.g. Amazon). Before you close any accounts, make a list of the following:

- Electronic Devices
- Email/Messaging Services, Social Media Accounts
- Payment/Money Management Information
- Shopping and Video/Movies/Music Accounts
- Online Cloud Storage

Once you've made a list, ask yourself:

- 1. If I delete/get rid of this right now, what would be the consequences?
- 2. Does anyone else need it?

For instance, does a surviving spouse use the credit card to pay bills? Are their reward points that have accumulated? So we need to check their email to make sure we've captured all accounts? In other words, please think through possible unintended consequences <u>FIRST</u> before closing accounts.

## Tasks to delegate to anyone asking "How can I help?"

Your friends and family want to help and here are ways they can.



#### **Household Chores**

- Meal planning, grocery shopping and food delivery
- Household help like laundry, cleaning, helping with pets
- Mow the lawn or help with yardwork
- Keeping a detailed list of gifts, flowers, and food being brought by friends to help with thank you notes down the road



#### **Kids & Family**

- Kids and childcare scheduling, play dates, driving, etc.
- Logistics for out-of-town family and friends
- If helpful, ask a family member or friend to stay at your or loved one's home to care for the house, pets, or help with logistics or visitors.



#### **Research & Information**


- Insurance claims and policies
